TERMS AND CONDITIONS

- 1. Trade must commence by 1000 on the event day and will continue until 1600
- 2. Vehicles must be unloaded and removed from event site by 0930 and may not be brought into the event site again until after 1600.
- 3. On the event day, the stallholder must ensure that the stall is maintained having regard to the safety of the general public and the promoter must allow regular inspection by the Love Yeovil representative and carry out any alteration required. Heavily laden stalls must provide load spreading feet to protect the surface of the market area.

- 4. The stall and/or goods must be kept within the confines of the pitch and all gangways must be kept clear.
- 5. Traders/Promoters must ensure that the area around their stall is kept clear of litter/leaflets from the stall and must take their litter home for disposal.
- 6. Advertising noise levels such as shouting, loudspeakers, recordings, the playing of radios or any other noise must be strictly controlled and kept to a minimum.
- 7. If the promoter/trader is unable to attend the event he/she must advise Alice Edmonds from Love Yeovil in advance preferable by 2nd December at the latest (Tel No: 07946 378 203 or via email <u>alice.edmonds@outlook.com</u>)
- 8. The site allocated will be available to the organisation/trader only for the promotion/activity in the type of promotion/activity/trade specified in his/her application form.
- 9. The promoter/trader may not sub-let or otherwise attempt to dispose of the pitch allocated.
- 10. The Love Yeovil, Town Council, South Somerset District Council and Yeovil Chamber of Trade & Commerce shall not be responsible for any loss, damage or injury caused to any person because of the condition or construction of any stall or by the equipment or goods placed on or around the pitch.
- 11. Any charges for stalls are payable in advance to Love Yeovil.
- 12. No refunds will be issued for pitch fees paid.
- 13. Promoters/traders must not make available items which are likely to encourage a breach of the law or are illegal. If there are any grey areas in this respect the decision Love Yeovil is final.
- 14. The promoter/trader must hold a valid insurance policy for public liability for claims up to £5,000,000 and produce evidence of such a policy being in force and that the premiums have been paid must be supplied to Love Yeovil 21 days in advance of the event (i.e. by 17th November 2019).
- 15. The promoter must also produce and supply, no later than 21 days in advance of the event, a full risk assessment for their stand at the event.

EVENT ABANDONMENT

Love Yeovil decides whether it is viable to hold a market, taking into consideration weather conditions, permit safe practice in erection of stalls, canopies, or any danger to the general public. (Very strong winds, blizzards, snow, ice, gas leaks, bomb threats, etc) during setting up between 1500 - 1545 or at any other time of the event day if conditions worsen.
